Important Message about Mailed Newsletters

This change will affect primarily those members who have opted to pay for a paper copy to be sent by postal mail. That option will no longer be available as of January. You may have noted that stamp prices recently increased 2 cents, and it now costs 60 cents to mail a first class letter. Postage for mailed newsletter copies has also gone up (\$0.84 . Members who do not have digital access via phone or computer will need to acquire newsletters at the monthly general meetings for \$3 or by using a computer at a local library, or by asking a friend or family member to print one for them. Phone access and library access will also require establishing an email account, but those can be had for free from Google or Yahoo. Hello to everyone. I want to update you all on our classroom expansion project. We have been raising funds all year to reach our fundraising goal. RGMS is a 501C(3) non-profit organization, and your tax deductible donation is so very important to our society. Currently, we have raised over forty thousand dollars toward our goal. absorbs lead in the soil. Technology is moving so quickly.

Rory has a busy life with his wife and two small children, but he is also excited about school and appreciates that the society's \$1500 scholarship will help him reach his educational goals.

Right after the Society awarded Rory his scholarship, the scholarship committee received four additional Scholarship requests from the University of Nevada, Reno!. They included applications from a civil engineering major, a student studying to be a meteorologist, a geology major getting a Master of Science degree, and a first-year Ph.D. student from the mining engineering department. Her project is for a fully immersive teleoperation platform for mining equipment. There seems to be a lot of need for more scholarships to support education.

The Society has budgeted \$1,500 per year for Scholarship awards; however. there are additional options to support deserving students. For example, if ten society members would be willing to donate \$100 each, we could enable an additional scholarship that could benefit a needy student. Summary of October 12, 2022 BOARD MEETING MINUTES

President **Dean Sizemore** called the meeting to order at 6:00 PM. Vice President **Steven Smith** led the pledge of allegiance. The Secretary's report can be reviewed upon request by contacting **Steve Norman**. The Treasurer's report is available for review by getting in touch with **Robyn Howard**.

The Rock Building Manager **Linda Johnston** reports financials look good with money available to begin the upgrade of the building.

School: The new lapidary equipment is making money for society. The new invoice system for a student taking classes is working well as a decreasing balance as classes are taken.

Volunteer Director **Terry Bush** announced that **Patrick Davis** will continue as the temporary Shop Director.

Craft Fair: **Theresa Langhans** reported a successful event last month with vendors doing pretty well.

Social Media: **Sven Sander** reports the Facebook group with 18,476 views with eleven new followers. There have been 188 Facebook groups with 13,534 views. There were 76 posts which is up 200%. Seven mail chimp blasts.

Tech Manager **Breia Sanders** reports that the website has 18,204 views with 124 visitors. There were 2,329 website activities with 2,186 new users to the website.

Field Trip: **Eric Fendelander** reports that the field trip to Gabbs went well and the Las Vegas group left with some good material.

Membership: Director **Janet Longueira** reports RGMS currently has 508 memberships which totals 929 members.

New Business: Vice President **Steven Smith** explained a proposal regarding RGMS affiliation. Currently, we work with CFMS (California Federation Mineral Society) mainly for our insurance needs which currently cost \$8.00 per member. Nevada is in the Rocky Mountain Federation geographic area and their insurance plan cost is \$1.50 per member. The proposal is to get all the information possible from both organizations to determine which plan is best for RGMS. Private insurance could also be considered. The process could take up to a year.

New Business: VP **Steven Smith** discussed the need for legal waivers for RGMS. There are many instructors, field trip leaders, and other people representing the Society that should have a legal waiver on file. Society members doing volunteer work should be protected as much as possible to prevent problems for the individual or the society. The legal form could be signed at general membership or during renewals of membership. A legal waiver is to be reviewed by a lawyer.

Future Rockhounds of America

Future Rockhounds of America is off to a great start after our summer break. At our October meeting, **Steve Norman** taught us about volcanoes and the minerals and rocks formed when a volcano erupts. Many questions were answered: Why does pumice float? Why is obsidian a rock, and not a mineral? How is volcanic ash good for plants? What is a tectonic plate? How do volcanoes form, in the first place? After the lesson, our students each received two mineral specimens for their collections, and then we painted rocks with a Halloween theme. Lots of fun was had by all. In November, we revisited volcanoes in a lesson about mountain building. We learned about batholiths and the carbon cycle. We learned about how the Sierra Nevada Range was formed, and the forces that created Devil's tower. This time, our students used yarn, beads, mica and other small mineral pieces to build their own mountain collages, and received another specimen for their collection. One of our students brought a very large, amazing agate nodule that she found right outside of her house! Another pitched in as the class ended, and had most of our mess cleaned up before we knew it. We've got a great group of kids, parents and grandparents! I hope you'll join us for our next class on December 17th, at the Rock Building at 480 S Rock Blvd in Sparks, from 2:00-3:30 pm, when we will be learning about the weathering and erosion of mountains and minerals.

Kid's Corner

Some of the oxygen that we breathe starts from, of all places, the Sahara Desert!. Now that is weird. Spread over eleven North African countries amounting to almost four million square miles of land, the Sahara Desert is the largest hot desert in the world. Deserts are dry and dusty places where the wind blows about 100 million tons of dust into the air every year. The winds move a lot of this dust to the Amazon Basin in South America, a distance of 6,000 miles from Egypt to Brazil.

The wind-borne dust from the desert attaches to the moisture in the humid jungle air to form raindrops and create clouds. Ever wonder why clouds are grey or even black? It is because of all those dust particles!

This process is a good thing because every time it rains or snows, dust is deposited providing food for plants to grow all over the world. The rainwater flows into the streams and rivers and so it is not wasted either. The river water with all that dust runs into the ocean and provides food for phytoplankton and blue-green algae. These tiny plants use nutritious water, carbon dioxide, and sunlight to give off oxygen that every living animal uses to breathe.

It is estimated that for every three breaths you take, the oxygen for two comes from ocean algae and the oxygen for the other breath from vegetation on the planet. Trees, algae, and many plants all over the world get some of their nutrition from places like the Sahara Desert.

CFMS Convention Visalia, CA,
11/11/22

The fall meeting of CFMS Officers and Chairs was held November 11 at the Wyndham Hotel in Visalia CA. which is the usual location for the Fall meeting. Several items were addressed at the meeting that RGMS may have some interest in:

Officers for 2023 were elected: President—Kim Fiala, Roseville GMS; 1st VP and President Elect, Bob Rush, Mother Lode GMS; 2nd VP—Heidi Hall, Reno GMS, Treasurer—Diane Cook, Ventura, and Secretary—Frank Van Hecke, El Dorado GMS. The officers were installed at the banquet that evening.

Due to increases in the cost of the public liability insurance CFMS provides for its member societies/clubs, CFMS found it necessary to increase the per member cost to \$7. This amounts to a \$1 increase (less than the cost of a cup of coffee or bottle of drinking water). The total amount due is \$9. The cost breakdown is \$2 for the CFMS dues and \$7 for the mandatory insurance.

Costs also impact Camp Paradise and the fee will need to increase. Camp Zzyzx may no longer be available. There is a new award for Juniors, the Junior Achievement Award as well as an award for best case by a junior at a CFMS show. CFMS is financially solvent, but has little available for operating expenses. Historian Steve Collett announced that digitizing of early newsletters is nearly complete. A committee was established to investigate locations in the cloud to store CFMS documents rather than as paper. Museum director commented that cases need tempered glass to foil smash and grab thefts. The Golden Bear nominee for 2022 was announced. Endowment raffle awards were distributed, and the 2023 CFMS Convention was announced for Lodi, CA June 23-25 at the Grape Festival grounds. Ventura will host the CFMS/AFMS convention in 2024, dates to be determined.

Representatives were reminded that the Federation officer reports are due, and that societies must report individuals and not simply number of family memberships for insurance purposes.
