Education Outreach

Reno Gem and Mineral Society Education Outreach made seven classroom presentations from November 18 through December 7, 2021: Gerlach Elementary School (ES) one classroom, Anderson ES two classrooms over two days, Lena Juniper ES two classes, Hidden Valley ES two classes. The hour-long presentation for each class gave about 185 students information on minerals and how the rock cycle works. The theme is that minerals are used all the time; for example, how when an electrical switch is turned on electricity flows. It is thanks to iron magnets spinning at Clark and Tracy power plants in the area that provide our power.

The students are encouraged to do well in school and think about pursuing a science education. Sam Knipmeyer reminds students that we have talked a lot about valuable resources below the ground. But that the most valuable resource we have is our students who will

soon be doing important jobs in our community. Every student is given a mineral gift and information to take to their parents about the

Reno Gem and Mineral Society. We get support from the Nevada Division of Minerals with stickers, pencils, and brochures that explain to parents how to keep safe in the wide and wild spaces of Nevada.

I want to thank Debbie Bush and Sam Knipmeyer for their help in giving the classes, and to Alan and Bobbi Metzger for furnishing student and teacher polished stone mineral gifts.

Board meeting notes for December 8, 2021
Steve Norman, Secretary

President **Dean Sizemore** called the meeting to order at 6:00 PM. Vice President Steve Smith led the pledge of allegiance.

Secretary's Report: **Steve Norman** has board meeting notes for anyone needing a copy and Board members have a copy via email. Corrections may be emailed. **Denise Sizemore** moved to accept the Secretary's report. **Rob Kendrick** seconded and the motion carried.

Treasurer's Report: **Robyn Howard** reviewed the Profit and Loss Statement for November 2021. Some highlights include a \$2,591 profit for the Craft Fair. The shop generated about \$900 in class fees for the month. The saw cutting generated just over \$300. Amazon "smile" sharing accounted for \$78. Highlighted expenses include \$651 advertising for the Craft Fair. The Christmas party rental at Lazy 5 was \$400. **Steve Smith** made a motion to accept the Treasurer's report. **Sue Webb** seconded. Motion carried. Robyn has worked on a running total but Quick Books does not allow it. She can do a quarterly year to date along with the quarterly budget meetings.

President: **Dean Sizemore** reminded all volunteers to report the hours to Terry Bush for his year-end report. The voice mail option on the Society's Charter phone system is being investigated by **Theresa Langhans**. Dean received lifetime memberships nominations from Board members. The list included **Tom Nichols and Virginia Keeley, Robyn Howard, Al Bolshazy, and Steve Norman**. After discussion, all were approved by the Board of Directors. The nomination will next be presented to the general membership for a vote to accept the nominations. **Philipp Weirauch** as historian decided that he will interview all the society's lifetime members to get their stories. Dean needs any contact information that a director's or officer's job entails. Please list these and submit to Dean so that this information becomes ancillary to the duty requirements making it easier for new people to fill the position if needed.

Vice President **Steve Smith** reviewed the spending proposal that needs to be considered before the first of the year. The treasurer's laptop is not working properly. **Julie Hilsabeck** made a motion to spend up to \$1,200 on a new machine with software. **Denise Sizemore** seconded. Motion carried. The Librarian also needs a computer to list the assets of the Library. The old Treasurer's laptop will be reformatted and given a try to run Excel. If the experiment does not work then a proposal was made to acquire a new librarian's machine for not more than \$700. **Eric Fendelander** made a motion to that effect, and **Janet Longueira** provided a second. The motion carried. The next proposal was to purchase Robert's Rules of Order for new board members and for other board members as needed. It was discovered that the Rules of Order can be downloaded for free on the website. **Patrick Davis** and **Phillip Weirauch** volunteered to donate \$100 each to purchase some hard copy books or pamphlets that can be shared by Board members. **April Young** as Librarian will be asked to make the purchase. The next proposal was for a \$1,500 scholarship for university or college students in Earth Sciences. **Steve Smith** made a motion to approve the scholarship fund. **Janet Longueira** seconded. This motion was approved. **Sue Webb** needs about \$140 for software for the *Conglomerate*. **Eric Fendelander** made a motion to accept with **Julie Hilsabeck's** second. Motion carried. The next proposal was to fund costs for delegates to attend American Federation of Mineralogical Societies and California Federation of Mineral Societies meetings. The cost Continued next page

is expected to be \$1,000. The value of belonging to these organizations was discussed for communication with other societies and low-cost insurance. **Webb Varnum** made a motion to accept and **Eric Fendelander's** second. Motion carried. A motion was made to hire a part-time bookkeeper to help keep up with the busy financial transactions of the society. Costs were discussed and the amount of help needed. This motion was tabled until further information is obtained. Another proposal was discussed regarding paying some of the society's key members an honorarium for all the work that they do. This was also tabled as we needed more information and all the ramifications that such an idea could entail. **Robyn Hoard** made the motion to table the bookkeeper and honorarium proposals with **Albie Longueira** second. Motion carried. The committee that works on these proposals that are to be considered for board action is made up of **Dean Sizemore, Steve Smith, Robyn Howard, Terry Bush, and Philipp Weirauch**. Anyone interested in joining this committee need only ask to be included.

Social: **Denise Sizemore** informed the group that the holiday party was attended by about 60 people. The party was a big success, lots of great food and Santa appeared. Set up and clean up went well and she thanks everyone for their help.

Door prize: Denise is going to take over from **Laura Jackson**. She plans to have themes for a while starting with fossils in January, and featuring hearts in February. Please donate if you can.

President Dean Sizemore: To keep budget and funding in the correct account it seems prudent to establish multiple accounts at the bank to keep track of funds. For example, a special event account for the Jackpot of Gems Show, building accounts for funds directed towards the building expansion and any donations, a scholarship fund for tracking scholarship outlays and any donations to the account. Dean needs to write a letter to the Glacial Bank to create these accounts. **Eric Fendelander** made a motion to create new accounts as described. **Webb Varnum** seconded. Motion carried.

The Rock Building (TRB): **Linda Johnston**--via Zoom/phone call--explained that plans are being made to upgrade the building for the society. **Patrick Davis**, building committee member, elaborated that if the society keeps the existing building space and adds a door, it could then occupy another even larger space for classroom and shop activities at a much better cost than by starting all over in the corner unit. Work is projected to be done in about a year. The society will help move Ace Motorcycle to the corner spot enabling the adjoining unit to be renovated to meet the needs of the society classrooms, shops, and storage.

Building: **Eric Fendelander** reported in process of obtaining a new water heater as the current machine is beginning to "act up."

Field Trips: On hold for the weather to moderate.

School: Director **Julie Hilsabeck** reports no classes in December. Open House will be open on Monday from 11 AM till 9 PM. Tuesday 1 PM to 9 PM, Thursday 6 to 9 PM, and Saturday from 10 AM to 5 PM. If you have some time please come by and get involved. Julie has scheduled TMCC classes with 8 students starting in January, then a class in March. Starting in January a stabilizing class will be offered Friday and Saturday. Casting will also start in January on Fridays. Mineral Identification is scheduled for Mason Valley in February and for RGMS in April. Webb Varnum will obtain money from the Treasurer to purchase identification kits. Once the kits are purchased by students, Webb will pay back the funds resulting in no cost to the Society
